### County-wide Traffic Calming Approach

- Regular/ongoing speed monitoring in settlement areas
- Information sharing and collaboration with Police, municipal partners and community
- Adopt posted speeds which are consistent with driving environment
- Need and prioritization of traffic calming measures
- Consideration of traffic calming measures as part of road design for planned road rehabilitation and land development
- Speed monitoring to evaluate effectiveness of traffic calming measures



# **Driving Environment**

- Driver's choice of speed can be influenced by several factors :
  - Peripheral vision and proximity of peripheral stimuli (built-up areas vs open space)
  - Driver cues lane width, shoulder width, sightlines
  - Road design horizontal/vertical curves, road cross section (urban vs rural), road surface
  - Driver workload signage, cyclists, pedestrians, parked cars, intersections, driveways
- Driver's perception of risk influences operating speed
- Driver's choice of speed is influenced by the visual scene in front of them and road characteristics



### Collision Data - Drumbo

### Historical collision data from 2013 to June 2018:

- 10 collisions involved parked cars/cars reversing
- 1 collision occurred within a stop-controlled intersection
- ▶ 1 turning movement
- 1 involved a pulled down hydro wire




### Speed and Road Safety Review Findings

- Speeds marginally excessive entering/exiting the village
- Speeds within the village not excessive
- Posted speed (50 km/hr) beyond the built-up areas is ineffective
- No apparent trends in speed related collisions





# Speed Data - Bright





### **Collision Data**

- Historical Collision Data (2013 to June 2018):
  - ─ 0 collisions within the village limits



### Speed and Road Safety Review Findings

- Excessive speeds at east/west approaches entering the village
- Speeds marginally excessive at north/south approaches
- Reduced speed zones beyond the built-up areas are ineffective



### Recommendations - Immediate

- Modify speed zones on Oxford Rd 8 (John St) to match limits of built up areas
- Install additional 50kph speed signs on Oxford Rd 22 (Baird St S)
- Ongoing speed monitoring
- Reassess need for electronic speed feedback signs on Oxford Rd 22 (Baird St S)
- Ongoing Police enforcement and speed data sharing

Please find a sketch of the areas proposed to use for the event attached.



#### Information:


Section 7(4) of the Ontario Building Code Act requires that an annual report be prepared and presented to Council on building permit fees collected and the cost to run the department.

The total fees collected by the building department in **2018** was **\$153,089.00**. The total number of permits issued was 124, with an estimated construction value of **\$15,543,771.00**.



And further that Council accept the tender submitted by Metro Freightliner, Brantford, ON for the supply of a new 2020 Freightliner 114 SD chassis including Viking-Cives dump/sander and related snow plow equipment as specified for a total amount of \$297,303.00 including HST.

## **Background:**

Tenders were sent to six area truck chassis dealers for a new tandem truck chassis including snowplow, wing and combination dump/sander body. Three bids were received, all of whom meet specifications. This truck replaces the 2009 Sterling Tandem axle truck and snow equipment which will be disposed of once we take delivery of the new truck.

#### **Analysis/Discussion:**

Metro Freightliner of Brantford, ON is not the low bid for a new 2020 Freightliner 114 SD chassis with Viking-Cives combination dump/sander body, snow plow and wing for a total of \$297,303.00 including HST. Delivery of the chassis is expected in June/July and then Viking-Cives will install the plow/wing and dump/sander body. Delivery of the completed unit is expected to be December 2019.

Carrier Centers of Woodstock, ON is the low bid for a new 2020 International HV513 chassis with Viking-Cives combination dump/sander body, snow plow and wing for a total of \$295,947.00 including HST. Delivery of the chassis is expected in October and then Viking-Cives will install the plow/wing and dump/sander body. Delivery of the completed unit is expected to be April 2020.

Staff's recommendation to council is to go with Metro Freightliner. It is the shorter lead time to receive the completed unit. Unit 1-08 2009 Sterling, is the unit being replaced. The safety on this unit expires the end of November 2019, staff will be able to make due without this unit for a short period of time. The cost to safety the vehicle and maintain it until April of 2020 would cost more than the difference in the price of the International. The net difference between the Freightliner and the International is \$1221.12.

#### BY-LAW NUMBER 2122-2019

A By-Law to amend Zoning By-Law Number 1360-2002, as amended.

WHEREAS the Municipal Council of the Corporation of the Township of Blandford-Blenheim deems it advisable to amend By-Law Number 1360-2002, as amended.

THEREFORE, the Municipal Council of the Corporation of the Township of Blandford-Blenheim, enacts as follows:

- 1. That Schedule "A" to By-Law Number 07-2003-Z, as amended, is hereby amended by changing to "AB-7" the zone symbol of the lands so designated "AB-7" on Schedule "A" attached hereto.
- 2. That Section 8.4 to By-law Number 07-2003-Z, as amended, is hereby further amended by adding the following subsection at the end thereof:
- **\*\*8.4.7** LOCATION: Part Lot 22, Concession 11 (Blenheim), AB-7 (Key Map 14)
- 8.4.7.1 Notwithstanding any provisions of this Zoning By-Law to the contrary, no *person* shall within any AB-7 Zone *use* any *lot*, or *erect*, *alter* or *use* any *building* or *structure* for any purpose except for the following:
  - all uses permitted in Section 8.1 of this Zoning By-Law,
- 8.4.7.2 Notwithstanding any provisions of this Zoning By-Law to the contrary, no *person* shall within any AB-7 Zone *use* any *lot*, or *erect*, *alter* or *use* any *building* or *structure* for any purpose except in accordance with the following provisions:
- 8.4.7.2.1 Special Provision for an Existing Storage Building

Notwithstanding any other provision of this Zoning By-law to the contrary, the storage building *existing* as of February 20, 2019, shall be located no closer than 4.2 m (14 ft) from the *rear lot* line.

8.4.6.3 That all the provisions of the AB Zone in Section 8.2 of this Zoning By-Law, as amended, shall apply, and further, that all other provisions of this Zoning By-Law, as amended, that are consistent with the provisions herein shall continue to apply mutatis mutandis."





PT OF LOT 22, CONCESSION 11 (BLENHEIM) TOWNSHIP OF BLANDFORD-BLENHEIM



#### BY-LAW NUMBER 2122-2019

#### **EXPLANATORY NOTE**

The purpose of By-Law Number 2122-2019 is to rezone the lots to be severed and enlarged by Consent Application B18-23-1, from 'General Agricultural Zone (A2)' and 'Agri-Business Zone (AB)' to 'Special Agri-Business Zone (AB-7)' to ensure the zoning of the lands is consistent with the lands to be enlarged, to which the parcel will be added. A special provision is required to permit a reduced rear yard depth of 4.2 m (14 ft) to recognize the location of the existing grain storage building on the lot to be severed.

The subject lands are described as Part Lot 22, Concession 11 (Blenheim), Part 1, 41R-2528, in the Township of Blandford-Blenheim. The lands are located on the northwest corner of Oxford Road 8 and Hubbard Road, and are municipally known as 836459 Hubbard Road.

The Township of Blandford-Blenheim, after conducting the public hearing necessary to consider the application, adopted the amending By-law Number 2122-2019. The public hearing was held on August 1, 2018. No comments or concerns were received from the public.
