# Addressing Food and Organic Waste in Ontario, EBR Registration No. 013-0094

#### RECOMMENDATIONS

#### **DISCUSSION**

#### **Background**

The MOECC is in preliminary discussions with stakeholders to inform them on the development of a Food and Organic Waste framework which will aim to:

- Reduce the amount of food that becomes waste
- Remove food and organic waste from the disposal stream
- Reduce greenhouse gas emissions that result from food and organic waste
- Support and stimulate end markets that recover the value from food and organic waste
- Increase accountability of responsible parties
- Improve data on food and organic waste
- Enhance promotion and education regarding food and organic waste

The Ministry is looking, through EBR 013-0094, to Ontarians to provide input towards the development of a Food and Organic Waste framework.

Report No: PW 2017-41 PUBLIC WORKS Council Date: AUGUST 9, 2017

The MOECC posted a discussion paper: 'Addressing Food & Organic Waste in Ontario' as a basis for preliminary discussions with stakeholders as it develops a framework for food and organic waste.

#### Comments

The County has recognized through its Waste Management Strategy that a curbside source separated food and organic waste collection service would be costly and would not capture 100% of the waste. The Waste Management Strategy recognized that rural areas the County are already doing a good job through the back yard composting program. With the introduction of the green cone composter there has been a larger percentage of food and organic waste being removed from the waste stream. The County of Oxford waste audit of curbside and landfill (which includes IC&I), conducted by AET Group, shows that there is still a significant amount of food and organic waste in the waste stream being landfilled.

The County is currently in the process, through the Zero Waste Oxford action committee and the Waste Reduction and Recovery Technologies review being completed by SLR Consulting, identifying technologies that will allow the County to work towards its zero waste goal. Food and organics waste have been identified as a large component of the waste stream and we have taken this into consideration when identifying Waste Reduction and Recovery Technologies.

The Oxford County Submission in response to the EBR Posting have made it clear to the Ministry that curbside source separated organics programs are costly and do not collect 100% of the food and organic waste. The Ministry needs to fund programs and allow for programs that handle food and organic waste outside of the curbside source separate organics systems.

The Oxford County Submission also point out that while curbside source separated programs work somewhat in an urban environment there is a significant greenhouse gas emission component of driving trucks through rural areas to pick up small amounts of organic waste.

#### **Conclusions**

The goal of removing food and organic waste from landfill is laudable. The Ministry needs to recognize that there may be options other than a curbside source separated food and organic waste pick up program. The Ministry also needs to provide funding in support of any program implementation.

# Addressing Food and Organic Waste in Ontario EBR Posting 013-0094

#### Overview

The Province should be commended for recognizing that food and organic waste make up a significant percentage of the waste going to landfill in Ontario. Food and organic waste currently make up one third of the waste stream. The Province has recognized that reducing the amount of food and organic waste going into the waste stream provides an economic and health benefit to the residents of Ontario. The removal of food and organic waste results in environmental benefits in the reduction of greenhouse gas from landfill and lessens the reliance on landfills in Ontario. Removing food and organic waste from landfill allows the turning of food and organic waste into valuable products and energy that recognize the benefit of a circular economy.

#### Comments

The County of Oxford recognizes the value of removing food and organic waste from landfill and provides the following comments:

- To process food and organic waste after it becomes waste should be secondary to reinforcing that to limit the amount of food and organic waste is the primary goal. In 2014 Ontarians produced 3.6 million tonnes of food and organic waste of which 60 % was disposed of at landfill. To process or landfill organic waste, is expensive in terms of processing, lost economic and energy value. Greenhouse gas production has serious environmental impact. The best process both economically and environmentally is to reduce the amount of food and organic waste produced.
- Removal of food and organic waste from the disposal stream will help lessen the reliance on landfills. The Province has proposed disposal bans from landfill which will require significant enforcement requirements on provincial staff. The disposal of organics in landfills that are not in Ontario will also need to be addressed. Trucking of waste out of the province to avoid the disposal ban would add to the production of greenhouse gas from the trucks.
- While a disposal ban will play a key part in the Province's Food and Organic Waste Action Plan the Province needs to ensure that there is sufficient processing opportunities through incentives for processors. A shortage of processors will drive the cost of processing up causing undo hardships for municipalities that provide food and organic waste collections for their residents.
- The Province has had meetings with industry stakeholders to discuss the modernization of ECA's and to register certain activities on the Environmental Activities and Sector Registry (EASR). If the Province implements a disposal ban on food and organic waste the Province will need to streamline the approvals process to ensure that the approvals for collection, storage, and processing can be quickly implemented to account for the increase of diverted materials.
- The government says it has an initiative "in progress" to move assessment and payment for financial assurance away from a paper based system to an electronic Environmental Compliance



Approval System (eECA's). There needs to be defined timelines and expectations for all ECA applications.

- The government has stated that it plans to reform several more approval processes for the waste management sector over the next 12 to 18 months. These include EASR registration, or even exemptions for:
  - 1. Alternative fuels production, and biogas and bioenergy facilities
  - 2. Waste Transfer and processing facilities (possible exemptions could include EASR registration for municipal facilities that store waste).
  - 3. The organics diversion sector (possible exemptions could include EASR registration for community composting facilities).

All of these proposed reforms would help support the government's broader objective to modernize approvals. The government began its modernization efforts in 2011 with the aim of replacing Certificate of Approvals with ECA's and EASR registration. A disposal ban on food and organic waste will require a fundamental change in the approval process with priorities given to processes involved in the food and organic waste collection, transport and processing.

- The Food and Organic Waste Framework proposed by the Province has a goal to reduce greenhouse gas emissions that result from food and organic waste. The Province needs to recognize that although a curbside source separated food and organics waste program may work in a densely populated area were the distance between collection points is small, the forced collection of source separated food and organics waste in sparsely populated rural areas is not efficient and is detrimental with its increased production of greenhouse gas from trucks.
- Current source separate food and organics programs in some municipalities have been experiencing difficulties with participation rates, quality of material and high processing costs. The Province needs to recognize and be forward thinking in realizing source separated food and organics curbside collection may not be the only way to collect and process food and organic waste at the curbside in municipalities.
- Along with a disposal ban will come a significant increase on the resources of municipalities to collect and process food and organic waste. The Province will need to put in a process that will fund food and organics waste programs at a fair and equitable level recognizing the difficulties municipalities with large geographical areas with a mixture of urban and rural demographics have.
- The Province needs to recognize that home composting may be an instance where Generator responsibility is the most effective route for the handling of food and organic waste in a residential environment. Funding needs to be provided to help educate residents in preventing the over-production of food and organic waste and how to deal with food and organic waste through home composting.

- 1. That the Ontario's Wildlife Damage Compensation Program Guide from the Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA) and presented by Councillor Jermey be received.
- 2. And Whereas Council of the Township of Oro-Medonte recognizes that The Ontario Wildlife Damage Compensation Program (OWDCP) provides compensation to eligible producers whose livestock and/or poultry have been injured or killed as a result of wildlife predation or whose bee colonies, beehives and/or beehive-related equipment has been damaged as a result of wildlife predation.
- 3. And Whereas livestock producers are passionate about caring for their animals, creating a sustainable environment for future generations and providing high-quality livestock to represent the industry.

- b) rely more heavily on the opinions of the Municipal Investigator, as they are experienced, familiar and knowledgeable with the Municipality's producers, as they continue to process genuine and valid applications.
- 6. And That correspondence be forwarded, under the Mayor's signature, to the Premier, the Ministry of Agriculture, Food and Rural Affairs, the Ontario Sheep Marketing Agency, the Beef Farmers of Ontario and Ontario municipalities requesting their support."

And further that Council approve no changes to our current Zoning By-Laws that would allow the keeping of "backyard chickens" in our urban areas within the Township.

# **Background:**

In late June 2017 staff received a written complaint and (3) pictures of a chicken coop that appeared to be set up in the side yard of a residential lot on Samuel Street in Plattsville. Staff directed our By-Law contractor to attend this address on July 18<sup>th</sup> and complete an inspection to ascertain if this person was in contravention of our Zoning Bylaw.

Staff sent the owner of this chicken coop a letter on July 20<sup>th</sup> explaining that chickens are only permitted to be raised in our Township on "agricultural zoned property" and that these chickens must be removed from this residential property within 14 days from this notice.

On July 24<sup>th</sup> the person who owns this chicken coop contacted my office and was very upset in having to remove these chickens as per my letter.

This person demanded an appeal of my decision. Staff consulted with CAO Mordue and we decided that staff would prepare a report for Council and the owner of this chicken coop would attend our next Council meeting and appeal her case. Staff requested the owner of this chicken coop to send her appeal in writing and it will be part of my report to Council. Staff would also share my report with the owner of this chicken coop prior to attending the September 6<sup>th</sup> meeting.

# **Analysis Discussion:**

Several municipalities in Ontario have considered adopting some type of standard operating policies that would permit backyard chickens. Some issues associated with keeping chickens in urban areas are complaints from neighbours about noise and odours.

There are municipalities in Ontario that allow back yard chickens but the property owner must have a lot size of no smaller than one acre. Some municipalities have several restrictions including set backs from their neighbours property and also institutional uses such as churches and schools.

Our current zoning definitions considers chickens part of a "Farm" use and they are only permitted on an agricultural zoned property.

Permitting backyard chickens is a policy decision for Council.

Staff would recommend to Council that our Township follow our current Zoning By-Law Number 1576-2009 and only allow chickens on properties that are considered a Farm.

# Re: Chickens on Residential Properties

In response to your letter dated July 20, 2017, I disagree with your finding and am appealing your request (order?), to remove my 3 chickens. I think the suggestion is cruel and inhumane.

According to the by-law I am within my legal rights.

In your letter you have outlined the definition of the word "farm". It goes on to provide details of what might take place on a farm, including, "....farms devoted to the hatching, raising and marketing of chickens.....". I am neither hatching, nor raising to market chickens. I have 3 young chickens that are quiet, discrete, well kept, free of offensive odours. They are my pets. I'm enjoying them the way some may enjoy having 3 cats. They pose no threat to anyone, in any way.

Below I have sited pertinent paragraphs from the Township By-Laws.

Paragraph 4.9.1. lists the animals which are prohibited. (Which I haven't bother to list)

There is nothing that states one can not have 3 chickens Ina residential zoned area.

#### 5.1 General Provisions

- 5.1.1. Every owner of an animal shall ensure that the animal enclosure provided for the animal meets the following requirements, regardless of whether the animal enclosure is located indoors or outdoors
- 5.1.2. The animal enclosure shall be of size and in condition such that the animal may:
  - 5.1.2.1. Extend its legs, wings, and body to their full natural extent;
  - 5.1.2.2. Stand
  - 5.1.2.3. Sit
  - 5.1.2.4. Perch
- 5.1.4. The animal enclosure is of such a nature and condition that the animal contained therein would not be harmed and its health would not be negatively affected for the reason of being placed in such an animal enclosure.

- 5.1.5. Every animal contained therein may be readily observed unless the natural habits of the animal require otherwise.
- 5.1.6. The animal enclosure is kept clean and sanitary condition.
- 5.1.7. The animal enclosure is kept clean of offensive odour.
- 5.2. Additional Provisions for Outdoor Animal Enclosures
- 5.2.1. Except for the keeping of animals on lands zoned for agricultural purposes no person shall keep, or cause to be kept, any animal enclosure for an animal outside a building or structure **UNLESS**:
- 5.2.2. the animal enclosure is in the rear yard; and
- 5.2.3. the animal enclosure, is located at least 3.1 metres (10 feet) from the property line and at least 6.1 metres (20 feet) from any school, church or residential building not located on the same lot.

Thank you for your time and consideration in this matter. I hope we can avoid a lot of unnecessary appeal process.

# Re: Chickens in Residential Area

Kindly add the below statement to my previous letter in response to your letter dated July 20, 2017. Thank you.

I was asked over the phone how I would like it if the neighbours had a horse. I believe it was in attempt to make me see it from another perspective. I said I wouldn't care what the neighbours had in their yard. And that is the truth.

Providing a neighbour keeps their animal contained and my grandchildren aren't at risk of any harm when they come to visit me, I don't care what the neighbours do. There are dogs on our street that bark every time I walk out my front door. And certainly every time I walk down the street, dogs are barking. My chickens don't make that kind of noise. Unless you've been told there are chickens in that back pen, you would never know it. The pen is completely concealed by vines and lattice. Living in Plattsville, at certain times of the year and especially in certain damp weather, you are overcome by the smell of the surrounding farm fields when the farmers have freshly spread. And on the other hand, you could be standing right beside my chicken pen and not smell them at all. Even inside the pen, there is little to no odour. I get up for work around 2:00 am. I have never seen a raccoon on our street. Our garbage pick up day is Fridays. Most of the neighbours on our street put their garbage out the night before. Most of them don't put the garbage in bins. If there were raccoons in our neighbourhood the garbage would be disturbed, torn up and all over the place. That is never the case.

Before we got the chickens we shared our plans with the neighbour. Their response was positive, so we went ahead with our plans. A few days later they changed their minds.

Sadly, it is not their decision to make. In an attempt to keep the peace however, I told them I would make every effort to stay on top of the maintenance and monitor things and <u>if</u> it became a problem, I would certainly do something about it. The chickens are NOT a problem. They are not even noticeable. I'm within the guidelines of the by-laws as far as distance from the property line etc and NONE of this should have gone as far as it has. When Ian first came to do the inspection, it should have ended at that.

- 4.42 "ERECT", when used in this Zoning By-Law includes *building*, construction, reconstruction and relocation, and without limiting the generality of the word, also includes:
  - 4.42.1 any preliminary physical operation, such as excavating, filling or draining;
  - 4.42.2 altering any *existing building* or *structure* by an addition, enlargement, extension or other structural change; and
  - 4.42.3 any work which requires a building permit.
- 4.43 "EXISTING", means existing on the date of passing of this By- Law.
- 4.44 "FARM", means any agricultural *use* and includes: apiaries; aviaries, berry or bush crops; breeding, raising or training horses or cattle; commercial greenhouses; animal kennels; farms devoted to the hatching, raising and marketing of chickens, turkeys, or other fowl or game birds, animals, fish or frogs; flower, vegetable or specialty crops; field crops; research and/or breeding stations; mushroom farms; nurseries, orchards; riding stables; tree crops; wood lots; seasonal farm shows and such accessory *uses* or enterprises as are customarily carried on in the field of primary agriculture. A farm may include an *on-farm composting facility* and may also include a bunk house for seasonal farm workers provided that the bunkhouse is located on the farm on which the seasonal farm workers are employed and the bunkhouse is constructed or anchored in accordance with the Ontario Building Code. A bunk house shall not be used for more than 6 months in any calendar year.

(Amended by By-Law 1576-2009)

4.44.1 "FARM, REGULATED", means a *farm unit* that is regulated under the <u>Nutrient Management Act, 2002</u>, as amended, and its regulations or, a municipal Nutrient Management By-Law.

(Amended by By-Law 1563-2008)

- 4.45 "FARM AUCTION BARN", means a *building* or *structure* used predominantly as a livestock auction facility and may include the auction of agriculturally related chattels on an incidental or accessory basis only.
- 4.46 "FARM IMPLEMENT DEALER", means the *use* of land, *buildings*, or *structures* where farm vehicles and equipment are stored for the purposes of sale, lease, or hire and where farm vehicles and equipment are repaired or serviced.

## Background:

APEXPRO Consulting Inc. completed a fire service review in 2016 and in their final report they examined (2) options pertaining to Bright Fire Station. One of their options was to close Bright Station down completely and merge Bright fire-fighters and equipment with Plattsville Station Their second option was to leave Bright Station status quo.

Council hosted a "special "meeting on January 11<sup>th</sup>, 2017 at the Bright Station to permit APEXPRO Consultants to present their final report on closing Bright Station. A community signed petition was presented to Council at this meeting stating that "the Bright Fire Station remain open and running with Medical calls, and responding as well as fire call outs" At the January 18<sup>th</sup>, 2017 Council meeting it was recommended to support the APEXPRO Consulting Inc. Report and that the Bright Fire Station be consolidated with the Plattsville Station. Subsequently this report was defeated by Council and Bright Station was to remain open.

# **Analysis Discussion:**

At the June 21<sup>st</sup>, 2017 Council meeting staff was requested to look at the feasibility of purchasing and housing some sort of a used fire rescue vehicle in the current Bright Station with the idea of this rescue vehicle attending to all medical calls in the Bright fire area. An investigation was completed by staff to ascertain the cost of a decent used fire rescue vehicle that would be located in southern Ontario if possible.

Council supported staff's Tiered Response Agreement report FC17- 13 on September 6<sup>th</sup>, 2017 with the idea of reducing our current medical calls. Staff would suggest to Council that we wait and see what reduction in medical calls for all four stations can be obtained once this new agreement is operational. All future medical calls will be attended by one apparatus only which should be a pumper.

When the current Bright tanker is no longer "road worthy" it will be removed from service and not be replaced.

#### **Financial Considerations:**

• The purchase of a reliable used rescue vehicle that would meet our needs would cost from \$80,000 to \$140,000.





#### Background:

At the September 6, 2017 Council meeting staff was requested to check on the status of the budget for the Plattsville skate park and also check on the items that proposed to be excluded from the original design.

# Analysis/Discussion:

At the July 5, 2017 meeting Council approved a DIY design and repairs to the pavilion and shed in the Plattsville Park to a maximum of \$84,000 not including HST. Funding for this is to come from an approved Canada 150 Grant in the amount of \$27,720. The remaining \$56,280 would come from the development charge reserve account. Any funds raised in the community would offset the development charge reserve contribution. To date a corporate grant of \$5,000 was obtained through staff thus bringing the reserve contribution to \$51,280.

Attached to this report is a conceptual layout of the skate park. It's staff's understanding that all items shown in the design were part of the DIY package. The focus group reviewed the design and thought that Items labelled 10 and 11 were not needed but since they came with the package anyway it was okay to leave them in. Since the July 5<sup>th</sup> meeting staff were informed that the DIY package was no longer available and that all items would need to be purchased separately. When this was discovered these two items were removed from the plan in order to keep everything within budget.

The budget current stands at \$82,933. This is made up of:

To add the 2 deleted items back into the design there would be an increase of \$3,563 which would put the project over the \$84,000 approved on July 5<sup>th</sup>.


The approved budget for the Plattsville skate park budget is \$84,000. Current expenses for this project (estimated and actual) are \$82,933.
