To His Excellency Sir Francis Bond
Head, K. C. H. Lieutenant Governor of
the Province of Upper Canada &c &c &c

The Memorial of William
Holecroft, James Ingersoll, George
W. Marsh and Peter Canall Sheweth

That your Memorialists with
many others, Members of the Church of
England and inhabitants of North &
West Oxford, did deeply regret and also
suffer great inconvenience in the absence
of a Minister of the Established Church
until the Reverend John Rothwell came
to reside in the Neighbourhood

That Mr Rothwell has for
the period of two years regularly and
gratuitously officiated as a Minister
of the Episcopal Church in the Village
of Ingersoll.

That the Congregation has
been for some time so much on the
increase that the building in which
Divine Service has been hitherto attended
is now quite too limited in extent for
the number that assemble, and in Con-
sequence thereof a Meeting took place
at Ingersoll on the twenty third day
of September instant, for the purpose
of taking Measures for the erection of
an Episcopal Church in the village,
when

when a sum exceeding two hundred pounds
was subscribed. At that occasion your
Memorialists were named on the acting
Committee appointed for carrying such
measures into effect, as your Excellency
will be pleased to observe on reference
to the accompanying paper marked A

That it will appear to your
Excellency by the paper marked B that
this neighbourhood was recommended as
a Missionary Station under the charge
of the Rev^d Mr. Rothwell in October
last by the Bishop of Quebec.

That it was resolved at said
meeting that a Memorial should be
addressed to your Excellency by the
Committee, praying for an endowment
of said Church, and in pursuance
thereof your Memorialists most res-
pectfully intend that your Excellency
will be pleased to endow same, with
such other allowances as may have
been heretofore granted in similar
circumstances

And your Memorialists as in
duty bound will ever pray
