The last Will and Testament of Abraham Hagey of the Township of Blenheim in the County of Oxford in the District of Brock and Province of Canada I Abraham Hagey Considering the uncertainty of this life and being yet in the enjoyment of my usual mind memory and understanding (Blessed be allmighty God for the same) do make and publish this my last will and Testament in manner and form following that is to say First I will that my beloved wife Magdalena Hagey shall have the one third of the whole of my Estate real and personal during her life I Will that personal property shall be sold at public vendue and the money arising therefrom shall be applied for paying off my debts I will that my real Estate shall either be rented out or sold and that my Executors shall have the right to make choice of which way they judge best for my Heirs I will that my children shall all have share and share alike out of my whole Estate and I do hereby empower my hereinafter named Executors to make ^{and} deliver all such Deeds of conveyances and other instruments of writing as may be reasonably required for the renting or selling of my real Estate according to my hereinafore specified Will and I do hereby acknowledge and ratify the same to be as good and lawful as if I had signed sealed and delivered the same myself personally and lastly I do hereby nominate constitute and appoint my friend Jacob Hagey of
