In the name of God, I, Henry McHamberlain Hallcock, of the Township of East Missouri, of the County of Bedford and Province of Canada, person of the age of thirty two years, and being of sound mind and memory, do make publish and declare, this my last will and testament, in manner following, To Wit,

My will is, that my funeral charges, and just debts shall be paid by my executors and executor, hereinafter named. The residue of my estate and property, which shall not be required for the payment of my just debts, funeral charges, and the expenses attending the execution of this my will, and the administration of my estate, I give Devise and bequeath and dispose thereof as follows, that is to say: First I give and bequeath to my beloved wife Pamela Hallcock, the whole of my personal estate, goods and chattels of every nature or kind now

Second I give devise and bequeath, to my son Watson Hallcock a minor, his heirs and assigns, all that certain tract or parcel of land, situate lying and being in the Township of East Missouri County of Bedford and Province of Canada, containing one hundred Aeres more or less, being composed of the east half of lot No. thirty two, in the eleventh concession, of the Township of East Missouri aforesaid together with all the hereditaments, and appurtenants thereto belonging, or in anywise appertaining, to have and to hold, the premises above described to the said Watson Hallcock, his heirs and assigns forever.

Third it is my will that my wife Pamela Hallcock, shall have the whole and entire control of the above described premises, for her and my son Watson Hallcock's support and maintenance, until the said Watson Hallcock shall become of the age of twenty one years and provided, the said Watson Hallcock, does not live to the age aforesaid, then and in that case, the whole of the above described premises, with all the appurtenances thereto belonging, It is my will that my wife Pamela Hallcock, shall have and hold during her natural life, as though I had given and Devised the same to her in the first place, and that after her death provided she should leave heirs, then to them forever.

Fourth It is my will that as soon as my son Watson Hallcock shall arrive at the age of twenty one years, as aforesaid, he shall take possession

possessions, have and hold, to his own use and benefit, the above described premises and appurtenances thereto belonging, save and except, that he shall provide my wife Pamela Mallock, shall remain my widow, support and maintain her, in a comfortable and decent manner, so long as she may remain as such my widow.

Fifth It is my will further that my executors, or executrix, shall soon as possible, after my decease, and to the best advantage they can, lease or rent, my farm, the premises described above, and with the rents accruing or coming from the same, to pay and cancel a debt I now owe to the estate of the late James Burdett deceased, which is about Eighty five pounds, more or less reserving the house, and two acres of land immediately surrounding the house, (not interfering with the barn) for the use of my wife, provided she should wish to occupy the same, that it is my wish that my executors shall not allow any timber to be cut on the above mentioned land, nearer than to within forty rods, of the western limit of said described premises.

And lastly I hereby nominate and appoint my esteemed friend and brother in law William Powell, of the Township of Blandford, County of Oxford and Province of Canada, and my esteemed friend William C. Brown, of the Township of East York County of Oxford, Mechanics, Executors and my wife Pamela Mallock, executrix of this my last will and testament, hereby revoking all former wills by me made.

In Witness Whereof, I have hereunto set my hand and affixed my seal this tenth day of March in the year of our Lord one thousand eight hundred and fifty nine.
