Whereas the above bound James Harris the Elder has this day been
appointed the Guardian of the person and property of the said
Miles Harris by William Desjardins Esquire the Judge of the
Superior Court of the County of Bedford. And the said James Harris the
Elder hath as he is required by law to do agreed to give security to the
said Miles Harris for the due discharge of his duties as
such Guardian. Now the Condition of the above will and Bond
or Obligation is such that if the said James Harris the Elder do and shall
faithfully perform the trust reposed in him as such Guardian
and that he the said James Harris the Elder his Executors or administrators
will when the said Miles Harris shall become of the full age of
lawfully one year or when ever the said Guardianship shall be
determined or sooner if there is required by the Judge of the said
Court pending to the said Miles Harris or to his Executors or
administrators a true and just account of all goods monies
interest rents profits or property of the said Miles Harris which

That Reuben Harris formerly of the Township of Denbigh

Month of April in the year of our Lord one thousand eight
hundred and fifty one was a brother of your petitioner. That
