a full, true, and perfect Inventory of the Goods and Chattels, Rights and Credits of the said
deceased, in the Registry Office of the Surrogate Court of the County of Oxford, when you shall
be thereunto lawfully required. And you further swear that the Goods and Chattels, Rights
and Credits of the said deceased at the time of his death amounted to the sum of *One hundred*
and twenty five pounds in the said *and you further swear that the said deceased died at the said*
Township of Deerham on or about the second day of August A.D. 1858.

This Instrument Witnesseth: That I
William Wellington Kimpton, of the Village of
Callsonburgh, Township of Durham, County of
Oxford, and Province of Canada, being of sound
and disposing mind, memory, and understanding,
do make, publish, and declare this to be my
last Will and Testament, hereby revoking and
making null and void all former last Wills
and Testaments, and writings in the nature of
last Wills and Testaments by me heretofore
made.

My Will is, first, that my funeral charges
and just debts shall be paid by my executors
hereinafter named.

The residue of my estate and property which
shall not be required for the payment of my
just debts, funeral charges, and the expenses
attending the execution of this my Will, and
the administration of my estate, I give, devise,
and dispose thereof as follows, to Wit:—

I desire that my house and lot at No. 5, east
side of Bidwell street in the Village of
Callsonburgh, be let at Rent till such time
as my executors think best to sell it, and
the proceeds thereof be applied for the benefit
of my beloved wife Almira, and my
two children, Henry and Adelaide.

I further desire that all the rest and residue of
my estate, real, personal, and mixed, which
I shall be seized and possessed, or to which I
shall be entitled, at the time of my decease,
be applied by my executors hereinafter named,
for the benefit of my beloved wife and two children
aforesaid, either by allowing them to retain paid

property, or by disposing of it as said executor
shall consider most advantageous,

And I do nominate and appoint
Pauising Bidleman, of Dereham, Oxford
County, and Province of Canada, and Jarvis
Mather, of Fairfield, Herkimer County New
York, executors of this my last Will and
Testament,

my name and affixed my seal, this
Twenty second day of July, in the year of our
Lord One thousand eight hundred and fifty

Know all Men by these PRESENTS, that we *Thomas John Stubbs* of the Township of North Norwich in the County of Oxford Esquire Administrator of all and singular the goods and chattels debts and credits of the late *George Stubbs* late of the County of Northampton Sheriff deceased. *William Wilson* of the County of Wiltshire in the County aforesaid Tinner and *George Wooditch* of the said County of Northampton are held and firmly bound to *His Excellency the Right Honorable Sir Edmund Wallker* *Grand Baronet General Governour of the Province of Nova Scotia*

and to his Successor and Successors in Office, in the sum of *Three hundred* Pounds of lawful money of the said Province, to be paid to *Her Majesty Queen Victoria* *or her Successors*

Successors; for which payment, to be well and truly made, we bind ourselves severally, our Heirs, and each of our Heirs, Executors, and Administrators, firmly by these Presents. Sealed with our Seals, and dated at *Woodsick* in the County of *Oxford* this *thirteenth* day of *August* in the year of our Lord one thousand eight hundred and *fifty eight*

THE CONDITION of this obligation is such, that if the within bounden *Thomas John Stubbs*

Administrator of all and singular the goods, chattels, and credits of *George Stubbs* deceased, do make, or cause to be made, a true and perfect inventory of all and singular the goods, chattels, and credits, of the said deceased, which have or shall come into the hands, possession, or knowledge of *him* the said *Thomas John Stubbs* or into the hands and possession of any other person or persons for *him* and the same so made, do exhibit or cause to be exhibited into the Registry of the *Supreme Court of the County of Northampton* on or before the *last* Monday in *March* next ensuing, and the same goods, chattels, and credits, and all other the goods, chattels, and credits of the said deceased, at the time of *his* death, which at any time after shall come into the hands or possession of the said *Thomas John Stubbs* or into the hands and possession of any other person or persons for *him* do well and truly administer according to law, and further do make or cause to be made a true and just account of *his* said administration, at or before the *thirteenth* day of *August* A.D. *1859* and all the rest and residue of the said goods, chattels, and credits, which shall be found remaining upon the said Administration account, the same being first examined and allowed by the Judge of the Court for the time being, shall deliver and pay unto such person or persons, respectively, as the said Judge by his decree or sentence, conformably to the provisions in a certain Act of Parliament, intituled, "An Act for the better settling Intestate Estates," and passed in the twenty-second and twenty-third year of the reign of Charles II, and also in a certain Act passed in the first year of King James II, contained, shall limit and appoint; and if it shall hereafter appear that any last Will or Testament was made by the deceased, and the Executor or Executors therein named do exhibit the same into the said Court, making request to have it allowed and approved accordingly, if the said *Thomas John Stubbs* within bounden, being thereunto required, do render and deliver the said Letters of Administration (approbation of such Testament being first had and made) in the said Court, then this obligation to be void and of none effect, or else to remain in full force and virtue.
