unto His Excellency the Governor General of the Pro-
vince of Canada in the sum of Two hundred pounds
of lawful Money to be paid to the said Governor
General or his Successors in office for which pay-
ments to be well and truly made We bind ourselves
and each of us by ourselves severally our and every
our heirs Executors and Administrators finally
by these presents sealed with our Seals dated this
fourth day of December in the Year of our
Lord one thousand eight hundred and forty seven.

The Condition of this obligation is such that
if the above named Robert Masson Administrator
of all and singular the goods Chattel and Credits of
James Masson deceased do make or Cause to
be made a true and perfect Inventory of all and
singular the goods Chattel and Credits of the said
deceased which have or shall come into the
hands possession or knowledge of him the said
Robert Masson or shall come into the hands
possession or knowledge of any other person
or persons for him and the same do make
or Exhibit or Cause to be Exhibited into the registry
of the Court of the District of Brock within
four months from the date hereof and the same goods
Chattel and Credits and all other the goods Chattel
and Credits of the said deceased at the time of
his death which at any time after shall come
into the hands or possession of the said Robert Masson
or into the hands or possession of any other person
or persons for him do well and truly administer
according to Law and further do make or
Cause to be made a true and just account
of the said administration at or before the


the first Monday in January next near or next to
one thousand eight hundred and forty nine
~~Expire term of one Year from the date of this~~ SM
Letters of administration granted to the said Robert
Marson. And all the rest and residue of the
said goods Chattels and Credits which shall be
found remaining upon the said Administrators
account the same being first Examined and
allowed by the Judge of the Court for the time being
shall deliver and pay unto such person or
persons respectively as the said Judge by his
deeree or Sentence conformably to the provision
in a certain Act of Parliament Entituled "An
Act for the better settling intestate Estates and
passed in the Twenty second and Twenty third Year
of the Reign of Charles, and the second and also
in a certain Act passed in the first Year of
King James the second Contained. Shall hunt
and appoint: and if it shall hereafter hereafter
appear that any last will or Testament
was made by the deceased and the Executor
or Executors therein named do exhibit the
same unto the said Court making request to
have it allowed and approved accordingly
Then if the said Robert Marson above
said as aforesaid, being thereunto required
do render and deliver the said Letters of ad-
ministration (approbation of each Testament
being first had and obtained) made in the
said Court Then this obligation to be void
and of none effect or Use to remain in full
force and virtue.
