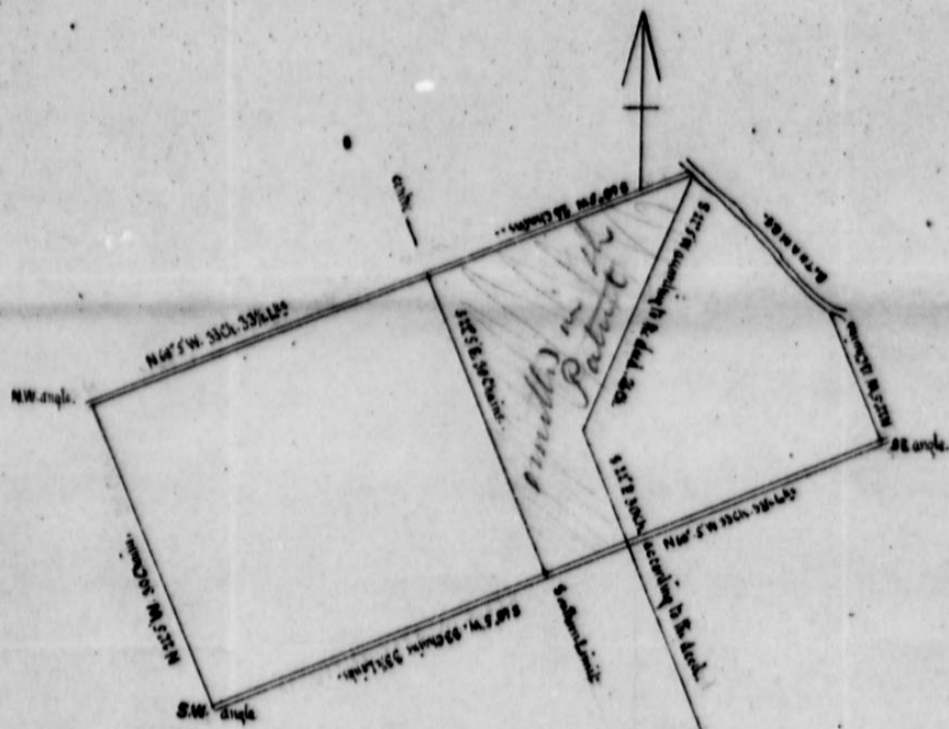

The party now therefore in possession of the patent should surrender it and to this end a form of surrender should be sent to Mr Lapointe to be indorsed thereon. The transfer should also be sent here in order that the Council may be convinced of ^{Mr Murray's} right to surrender. A certificate from the County Register is also necessary to show that no other transfer exists.
